Office Email Addresses Guidelines

- An office email authorization form must be submitted by the Regional Director or Schools Division Superintendent.
- Any changes to the authorized personnel must be reported to the Central Office with a revised office email authorization form.
- 3. The office email may be used only in official communication.
- It is not meant to be the official email of any one official or office in the division or region. Everyone is still enjoined to use their individual email.
- 5. Official communication and announcements from the Central Office will be sent through the office email.
